

RELEASE AND HOLD HARMLESS AGREEMENT

_____, on behalf of myself and on behalf of _____, a minor child (hereafter collectively referred to as "Participants"), do hereby release, acquit, and forever discharge **The Playroom, Inc.**, a Nevada corporation ("Playroom"), and each, every, and all of its officers, directors, agents, employees, representatives, and assigns from any and all actions, causes of action, claims, demands, costs and expenses incurred as a result of any injuries or property damage which may be sustained by Participants or third parties, as a result of Participants participation on the playground and playground equipment located at the Playroom's facilities.

I, the undersigned, understand, acknowledge, and agree that play on playgrounds and related playground equipment, including, but not necessarily limited to, bounce houses, jungle gyms, climbing walls, slides, swings, playhouses, and related play structures, is inherently dangerous, and can result in physical injury to Participants and others on the playground. I further understand, acknowledge and agree that Playroom does not select or supervise specific playground activities, games, jumps, exercises or acrobatic feats which Participants may attempt at the playground.

I, the undersigned, understand, acknowledge, and agree that playground activities can be extremely dangerous, and accept the risk thereof on behalf of myself and the minor child named above. I understand that Participants may suffer injuries or property damage from innumerable causes that may occur as a result of and among other things, accidents, acts of God, negligence, unpredictable actions of bystanders and other participants, and/or negligent acts of third parties, all of which may result in injury or property damage to Participants or third parties on a temporary or permanent basis and that Participants or third parties may be seriously injured. On behalf of myself and the minor child named above, I hereby assume the risk of injury or property damage, and I hereby waive and release the Playroom and each, every, and all of its officers, directors, agents, employees, representatives, and assigns from and against any and all claims, costs, and expenses in any way related to Participants use of the playground and playground equipment.

I acknowledge and agree that I am executing this Release and Hold Harmless Agreement freely, voluntarily, and independently, with full knowledge of the risks associated with play on playgrounds, and on behalf of Participants and any other person or entity that might make a claim on my or the minor child's behalf, or derivatively as a result of the death or injury of the Participants.

The undersigned covenants and agrees to indemnify, defend, and hold harmless the Playroom, and each, every, and all of its officers, directors, agents, employees, representatives, and assigns from and against claims, loss or expense raised or incurred by third parties and from and against any and all loss, claim, or expense (including reasonable attorney fees) which might arise out of, or in any way relate to, Participants use of the Playroom's playground and related playground equipment.

Should The Playroom, Inc. or anyone acting on their behalf, be required to incur attorney's fees and costs to enforce this agreement, I agree to indemnify and hold them harmless for all such fees and costs.

I certify that I have adequate insurance to cover any injury or damage I may cause or suffer while participating, or else I agree to bear the costs of such injury or damage myself. I further certify that I am willing to assume the risk of any medical or physical condition I may have.

In the event that I file a lawsuit against The Playroom, I agree to do so solely in the State of Nevada, and I further agree that the substantive law of Nevada shall apply in that action without regard to the conflict of law rules of that state. I agree that if any portion of this agreement is found to be void or unenforceable, the remaining document shall remain in full force and effect.
